1. Minutes Approved

Jen motioned to approve, Francois 2nds motion.

Jeff reminded council that we need to follow meeting rules to approve minutes. We approved last meeting's retroactively.

Jen suggests 1hour time limit set for meetings. The SCC will set agenda for future meetings at the end of each meeting.

2. Cafeteria Waste (Jen and Karen)

Jen researched a "share table" where students could leave unopened chips, milk, fruit, etc. District said "No way", as did Jeff Nalwalker, siting liability.

Rusty suggested educating students about not wasting food, perhaps through an assembly.

Lori suggested perhaps a food bank, or shelter could pick up a box each day. She will look into this.

We also discussed hiring a dishwasher to eliminate styrofoam plates and single use plastic cutlery. Jeff estimates we need roughly \$2,350./yr. to hire a dishwasher at \$13/hr. x 180 days. He will ask Chris Eplar, "district green guy", and Sebastian Vargus , head of nutrition, to see if each could come up with half for this fund.

Orchestra A regional orchestra is advertised on district web page. The closest one is at Canyon View, however, unfortunately, due to a difference in start times, our students are already in class when it meets.

4. Report on Extended Learning Opportunities
